



## 2017/2018 Access North & South Hunt Club

The 2017/2018 North & South Hunt Club Access Package has been designed to give members access to over **138,000 acres of prime hunting habitat** for the 2017 fall season; season dates are **September 1, 2017 through January 28, 2018** and the 2017 spring season; season dates are **March 1, 2018 through July 31, 2018**. See attached map for boundaries and access points.

This package will also include membership to the *Tejon Ranch Equestrian Center* which includes membership to the *Tejon Hounds* (please see attached write-up on this membership). Also included is membership to the *High Desert Hunt Club (HDHC)*, southern California's premier upland bird hunting club (please see attached write-up on HDHC membership). These two memberships represent a \$2,000 value in aggregate.

The 2017/2018 North & South Hunt Club Access Package includes many membership privileges. The package details are below. ### Details of 2017/2018 North & South Hunt Club Access Package

- **Season: September 1, 2017 through January 28, 2018 and March 1, 2018 through July 31, 2018**
- **\$11,000 for Individual Packages** (*Includes Spouse and dependents under 30 years of age*)
- **Individual package includes fourteen (14) pig options**
  - 7 pig options to be used during fall season; 7 pig options to be used during spring season
  - Additional pig options can be purchased for \$450 each (maximum 1 per season)
  - Guests hunting wild pigs may either use one of the member's allocated pig options or purchase one for \$450
- **Includes sixteen (16) guest passes**, each valid for forty eight (48) hours
  - 8 guest passes to be used during fall season; 8 guest passes to be used during spring season
  - Additional guest passes can be purchased for \$150 each (limit 5 total per season, per membership)

**Membership includes the following:**

- **Small game hunting (includes varmint)\*** across the entire North & South Hunt Club areas (See note below)
- **Bear\*** option available with membership at the rate of \$350 (See note below)
- **Bobcat\*** option available for purchase with membership at the rate of \$50 (See note below)
- **Upland bird hunting\*** across the entire North & South Hunt Club areas (See note below)
- **Waterfowl hunting\*** on the ponds and waterways throughout the entire North & South Hunt Club areas (See note below)

**Deer Hunting: Option available for \$2,500 with membership**

The goal of the Quality Deer Management (QDM) program is to enhance the overall population and quality of the deer herd. We have now had a number of years of aggressive management and are just now beginning to see the positive results; we will continue this management plan through the fall 2017 season and well into the future. In order to improve the overall quality of the bucks on the Tejon Ranch, the QDM program focuses on harvesting mature, heavy antlered bucks that do not possess the attributes to meet our management goal. Guided QDM deer hunts for North Hunt Club members will include a 2-day hunt over a 3 day period including accommodations, meals, transportation on the ranch and basic field care of game, **but does not include a guaranteed shot opportunity.**

**Lodging and Camping** Members in the North & South Hunt Club will have the ability to use cabins within the both hunt club areas, seasonal camp opportunities (Oso and Canary Camp), as well as dry camping at the campsites located at Crane Canyon and Vaquero. All of the lodging opportunities will be subject to availability. **All cabin lodging requires a two (2) night stay beginning on Monday, Wednesday or Friday.**

- **Venado Lodge** is located approximately six (6) miles from the Lebec entrance gate. This lodge has a fully equipped kitchen, sleeps fourteen (14), all the basic amenities and can be rented for \$350 per night.
- **Cazador Lodge** is located off of the Haul Road approximately 8 miles from the Old Headquarters Entrance. This lodge has a fully equipped kitchen, sleeps fourteen (14), all the basic amenities and can be rented for \$350 per night.
- **Bloom House** is located just inside the Old Headquarters Entrance. This house has a fully equipped kitchen, sleeps fourteen (14), all the basic amenities and can be rented for \$350 per night.
- **Habakern Cabin** is located approximately six (6) miles from the Lebec entrance gate. This cabin sleeps up to eight (8) people, has a generator, working kitchen and hot water. This cabin is in a great location to hunt any game within the South Hunt Club area. This cabin can be rented for \$250 per night.
- **Bear Trap Cabin** is located about three (3) miles past the end of the pavement up Bear Trap Canyon. This cabin sleeps up to eight (8) people, has a generator, working kitchen and hot water. This cabin is in a great location to hunt any game within the South Hunt Club area. This cabin can be rented for \$250 per night.
- **Canary Camp Area** is a seasonal camp and its availability is dependent on weather. This camp is dry (hunters must bring in water), but is a great location for all hunting. This camp area can be rented for \$100 per night or \$150 per weekend.

- **Oso Camp Area** is a seasonal camp and its availability is dependent on weather. This camp is dry (hunters must bring in water), but is a great location for all hunting. This camp area can be rented for \$100 per night or \$150 per weekend.
- **Crane Canyon Campground** is available for RV's and trailers. This is a dry campground with no hookups. There are limited spots available and will be based on a first come, first serve basis. All RV's and trailers will need to be removed at the end of each stay. *\*Note: RV's and trailers may be kept at the Crane Canyon Campground for \$500.00 per season.*
- **Vaquero Campground** is available for RV's and trailers. This is a dry campground with no hookups. There are limited spots available and will be based on a first come, first serve basis. All RV's and trailers will need to be removed at the end of each stay. *\*Note: RV's and trailers may be kept at the Vaquero Campground for \$500.00 per season.*

### Details and Basic Hunt Rules include:

Membership to the North & South Hunt Club is offered to outdoorsmen with the highest ethics. Members must comply with all California Department of Fish and Wildlife regulations, as well as Tejon Ranch access and hunting rules.

- **The possession of ammunition containing lead, whether or not accompanied by a firearm capable of firing such ammunition, is strictly prohibited on the Ranch.**
- All members, family members and guests (hunting or non-hunting) must have in their possession a valid hunting and/or access permit at all times while on Ranch property.
- All members, family members and guests must purchase liability insurance from Tejon Ranch at the rate of \$30.00 per year (September 1-July 31) prior to entering the Ranch. Each person, hunting or not, must carry the insurance. (No Exceptions)
- All pig tags must be embossed through the Wildlife Management Office prior to entering the Ranch. Tags are available for sale through the Wildlife Management Office.
- Tejon Ranch reserves the right to guide hunting trips on entire North & South Hunt Club area and the right to access and use all facilities within the area; there will also be other ranch activities, including but not limited to filming, public access events, and development planning activity that may limit access to portions of the North & South Hunt Club area periodically. Tejon Ranch also reserves the right to add, alter or cancel memberships at any time.
- For the 2017-2018 season, we will continue with our minimum age to hunt upland game on the Ranch to include anyone with a valid California hunting license (the age to hunt big game in California has not changed and will remain at 12 years of age with a valid CA hunting license). Anyone under 18 years old accompanying a hunting member on the Ranch must have a valid CA hunting license.
- No ATV's, motorcycles, quads or off-road vehicles are permitted on Tejon Ranch at any time. **NO EXCEPTION.** 4x4 vehicles are allowed.
- All gut piles must be buried a minimum of 2' within the entire North & South Hunt Club area and special care must be taken to eliminate micro trash from this and all areas on Tejon Ranch.
- All members are expected to take great care of this special piece of Tejon Ranch. The Ranch expects members to always leave the area better than they found it and communicate with Ranch management if any rules, regulations or the highest hunting ethics are not respected.
- Each member, whether returning or not, will be required to watch the Tejon Ranch orientation video.
